

Official Rules for the Mackie Limited Edition Survey Contest 2020

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. Odds of winning will depend on the total number of entries received. Void where prohibited by law.

1. ELIGIBILITY: The Mackie ("Sponsor") Mackie Intro and Outro Contest ("Contest") is open only to persons who have reached the age of eighteen (18) years old in their state or country of residence as of the date of entry. The Contest is subject to all applicable international, federal, state, and local laws and regulations and is void where prohibited, taxed, or restricted by law. Entrants under eighteen (18) years old must obtain parental consent before entering the Contest. Such consent may be given via e-mail or regular mail to the Sponsor at requirement. Sponsor Employees or any of its subsidiaries, affiliates, or agencies, or members of their immediate families, or persons living in same household of each, are not eligible to enter or win. 2. HOW TO ENTER: Contest begins 06/01/2020 at 10:00 a.m. PST US Time and ends 06/30/2020 at 11:59p.m. PST US time (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods: Create original music no longer than 60 seconds in length. Host your song on Soundcloud or Youtube, and send the link to podcast@mackie.com before 6:00pm PST, Tuesday June 30th. (No direct download submissions will be considered). Send a link to the music and write **Podcast Contest Submission** in the subject line and provide your name and address in the body of the e-mail. [1] Winner will be selected on or about 07/15/2020 and will win one [1] Mackie Producer Bundle. To Enter: To enter the Contest complete the survey via the designated link provided by Mackie. Entrants

must answer and submit all of the applicable questions in the survey form. Limit one (1) entry per person regardless of method of entry. With regard to online entries, in the event of a dispute about the identity of an entrant, each entry will be declared made by the registered account holder of the e-mail account used to submit at the time of entry, as long as that person meets all other eligibility requirements in these "Official Rules". The registered account holder is deemed to be the natural person who is assigned the e-mail account used to submit, online access provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail accounts associated with the submitted entry.
